- No food or drink allowed in the Gymnasium.
- Be Responsible Be Respectful
- Please make sure all lights out when leaving.
- Your membership will be immediately revoked and no refund with any of the above infractions.
- Thank you for abiding by these rules so APRD can continue to keep the Central Community Center Gymnasium and programming within the Center open to youth. By signing this Contract, you have agreed to the above.

Participant Waiver: This must be completed and signed prior to participation. In consideration for the foregoing, I for myself, my child, my executor's, administrators and assignee's, do hereby release and discharge all sponsor's, coordinating groups, volunteer's and any individuals associated with the activity, for all claim of damages, demands, actions and whatsoever in any manner arising or growing out of my or my child's participation in said event.
